- ✓ MACC signed and returned to the Department the Certification and Agreement for the Emergency Financial Aid Grants to Students. MACC intends to provide 100% of the funds received to its students.
- ✓ The total funds received by MACC from the Department was in the amount of \$81,683.00 pursuant to MACC's Certification and Agreement for the Emergency Financial Aid Grants to Students.
- ✓ The total amount of funds received for purposes of this Emergency Financial Aid Grants to Students is \$81,683.00.
- ✓ Total number of students who are eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and thus eligible to receive emergency financial aid grants under Section 18004(a)(1) of the CARES Act as of this report is 59.
- ✓ As of June 24, 2020, there has been 58 students who have received the checks representing the emergency financial aid grant.
- ✓ As a method used by MACC to determine who and how much students will be receiving, the total amount received from the Department of Education is equally given to eligible students.

Dear Students:

While uncertainty is still ahead of us, Medical Allied Career Center is dedicated to continuing to deliver all its programs through distance learning education. Our School President, Director of Nursing, Financial Aid Director, Instructors, and staffs are working extra hours to ensure continuity of your program.

The school currently monitors 59 active students in an online setting and delivery in a form of synchronous and asynchronous communications. Unfortunately, we will be continuing these methods a little bit longer until restrictions for California residents are lifted.

In order to continue with our programs, the school maintains all employees seven days a week while working long hours both from home and on-site location. While others cut hours, Medical Allied Career Center ensures all students that we will be here providing the services you deserve in order to continue your quest to become a license vocational nurse.

While we understand that most of you, if not all, are affected by the crisis and may be suffering some hardships, tuition and fees may be the least of your concern right now. As your Financial Aid Director, I'm here to inform you that your financial aid originally awarded to you is not affected by the COVID19 crisis. These Federal Student Aids will continue to fund your education as long as you are participating in the online classes. However, as you all know the out of pocket not covered by your Federal Student Aid is the student's responsibility to pay to the school. As we continue to provide your education through distance education, I ask that you make smart money management plan to pay your out of pocket tuition balance.

***A bit of good news: The Department of Education through CARES Act, issued an "Emergency Financial Aid Grants to Students" due to COVID19 crisis. This is a grant that you do not have to pay back and unrelated to your original financial aid but you must be eligible for Federal Student Aid and actively participating in the online classes to qualify for it. The grant can be between \$\_\_\_\_\_ and \$\_\_\_\_\_ depending on the number of MACC students who will qualify. This grant can be used to help pay for your own expenses or you can elect to have it applied to your out of pocket expenses.***
